Allows users to construct the Continuous Time Generalized Rapid Response CUSUM (CGR-CUSUM) <doi:10.1093/biostatistics/kxac041>, the Biswas & Kalbfleisch (2008) <doi:10.1002/sim.3216> CUSUM, the Bernoulli CUSUM and the risk-adjusted funnel plot for survival data <doi:10.1002/sim.1970>.

These procedures can be used to monitor survival processes for a change in the failure rate.

*Average Run Length for Bernoulli CUSUM*


---

**Description**

This function allows to estimate the Average Run Length (ARL) of the risk-adjusted Bernoulli CUSUM (see [bernoulli\\_cusum\(\)](#)) through a Markov Chain Approach (Brook & Evans(1972) & Steiner et al. (2000)) or exploiting the relationship with the Sequential Probability Ratio Test (Kemp (1971)). The function requires the specification of one of the following combinations of parameters as arguments to the function:

- glmmod & theta
- p0 & theta
- p0 & p1

Average run length of lower-sided Bernoulli CUSUM charts can be determined by specifying  $\theta < 0$ .

## Details

The average run length of a CUSUM chart  $S_n$  is given by  $E[\tau_n]$ , where  $\tau_n$  is defined as:

$$\tau_n = \inf\{n \geq 0 : S_n \geq h\}.$$

When `method = "MC"`, the average run length will be determined by the Markov Chain approach described in Brook & Evans (1972), using the risk-adjustment correction proposed in Steiner et al. (2000). The idea is to discretize the domain  $(0, h)$  into  $n_{grid} - 1$  state spaces, with  $E_0$  of width  $w/2$  and  $E_1, \dots, E_{n_{grid}-1}$  of width  $w$ , such that  $E_{n_{grid}}$  is an absorbing state. This is done using the following steps:

- $w$  is determined using the relationship  $\frac{2h}{2t-1}$ .
- Transition probabilities between the states are determined and 'transition matrix'  $R$  is constructed.
- The equation  $(I - R)ARL = 1$  is solved to find the ARL starting from each of the states.

When `method = "SPRT"`, the average run length will be determined by the relationship between the SPRT and CUSUM described in Kemp (1971), using the risk-adjustment correction proposed in Steiner et al. (2000). If  $N$  is the run length of a SPRT,  $P(0)$  the probability of a SPRT terminating on the lower boundary of zero and  $R$  the run length of a CUSUM, then:

$$E[R] = \frac{E[N]}{1 - P(0)}.$$

$E[N]$  and  $P(0)$  are completely determined by

$$G_n(z) = \int_0^h F(z-w) dG_{n-1}(w)$$

with  $F(x)$  the cdf of the singletons  $W_n$ . The integral can be approximated using the generalized trapezoidal quadrature rule:

$$G_n(z) = \sum_{i=0}^{n_{grid}-1} \frac{F(z-x_{i+1}) + F(z-x_i)}{2} (G_{n-1}(x_{i+1}) - G_{n-1}(x_i))$$

## Value

A list containing:

- **ARL\_0**: A numeric value indicating the average run length in number of outcomes when starting from state  $E_0$ .
- **ARL**: A data.frame containing the average run length (#outcomes) depending on the state in which the process starts ( $E_0, E_1, \dots, E_{n_{grid}-1}$ )  
**start\_val**: Starting value of the CUSUM, corresponding to the discretized state spaces  $E_i$ ;  
**#outcomes**: ARL for the CUSUM with initial value **start\_val**;
- **R**: A transition probability matrix containing the transition probabilities between states  $E_0, \dots, E_{t-1}$ .  $R_{i,j}$  is the transition probability from state  $i$  to state  $j$ .
- **h**: Value of the control limit.

The value of **ARL\_0** will be printed to the console.

## Description

This function can be used to determine control limits for the Bernoulli CUSUM ([bernoulli\\_cusum](#)) procedure by restricting the type I error alpha of the procedure over time.

## Details

This function performs 3 steps to determine a suitable control limit.

- Step 1: Generates `n_sim` in-control units (failure rate as baseline). If data is provided, subject covariates are resampled from the data set.
- Step 2: Determines chart values for all simulated units.
- Step 3: Determines control limits such that at most a proportion `alpha` of all units cross the control limit.

The generated data as well as the charts are also returned in the output.

## Value

A list containing three components:

- `call`: the call used to obtain output;
- `charts`: A list of length `n_sim` containing the constructed charts;
- `data`: A `data.frame` containing the in-control generated data.
- `h`: Determined value of the control limit.

**Details**

The Bernoulli CUSUM chart is given by

$$S_n = \max(0, S_{n-1} + W_n),$$

where

$$W_n = X_n \ln \left( \frac{p_1(1 - p_0)}{p_0(1 - p_1)} \right) + \ln \left( \frac{1 - p_1}{1 - p_0} \right)$$

and  $X_n$  is the outcome of the  $n$ -th (chronological) subject in the data. In terms of the Odds Ratio:

$$W_n = X_n \ln(e^\theta) + \ln \left( \frac{1}{1 - p_0 + e^\theta p_0} \right)$$

For a risk-adjusted procedure (when `glmmod` is specified), a patient specific baseline failure probability  $p_{0i}$  is modelled using logistic regression first. Instead of the standard practice of displaying patient numbering on the x-axis, the time of outcome is displayed.

## Value

An object of class `bercusum` containing:

- `CUSUM`: A `data.frame` containing the following named columns:
  - `time`: times at which chart is constructed;
  - `value`: value of the chart at corresponding times;
  - `numobs`: number of observations at corresponding times.
- `call`: the call used to obtain output;
- `glmmod`: coefficients of the `glm()` used for risk-adjustment, if specified;
- `stopind`: indicator for whether the chart was stopped by the control limit.

**Details**

Let  $K$  denote the run length of the Bernoulli CUSUM with control limit  $h$ , then this function can be used to evaluate  $P(K \leq x)$ .

The formula on page 543 of Brook & Evans (1972) is used if `exact = TRUE`. When `exact = FALSE`, formula (3.9) on page 545 is used instead, approximating the transition matrix using its Jordan canonical form. This can save computation time considerably, but is not appropriate for small values of  $x$ .

## Value

A list containing:

- `Fr_0`: A numeric value indicating the probability of the run length being smaller than  $x$ .
- `Fr`: A data.frame containing the cumulative distribution function of the run length depending on the state in which the process starts  $(E_0, E_1, \dots, E_{n_{grid}-1})$   
`start_val`: Starting value of the CUSUM, corresponding to the discretized state spaces  $E_i$ ;  
`P(K <= x)`: Value of the cdf at  $x$  for the CUSUM with initial value `start_val`;
- `R`: A transition probability matrix containing the transition probabilities between states  $E_0, \dots, E_{t-1}$ .  $R_{i,j}$  is the transition probability from state  $i$  to state  $j$ .

The value of `ARL_0` will be printed to the console.

with  $N(t)$  the counting process of all failures at time t, and

$$\Lambda(k, t) = \Lambda(t) - \Lambda(k)$$

with  $\Lambda(t)$  the summed cumulative intensity of all subjects at time t.

The starting time of the first subject who had an increase in failure rate as well as the estimated increase in the hazard rate are shown in the output. The CGR-CUSUM is determined as

$$\max_{1 \leq \nu \leq n} \left( \hat{\theta}_{\geq \nu}(t) N_{\geq \nu}(t) - \left( \exp \left( \hat{\theta}_{\geq \nu}(t) \right) - 1 \right) \Lambda_{\geq \nu}(t) \right),$$

where

$$N(\geq \nu)(t) = \sum_{i \geq \nu} N_i(t),$$

with  $N_i(t)$  the counting process for the failure at time  $t$  of subject  $i$  and

$$\Lambda_{\geq \nu}(t) = \sum_{i \geq \nu} \Lambda_i(t),$$

where  $\Lambda_i(t)$  is the cumulative intensity of subject  $i$  at time  $t$ .

When `maxtheta` is specified, the maximum likelihood estimate of  $\theta$  is restricted to either `abs(maxtheta)` (upper sided CGR-CUSUM) or `-abs(maxtheta)` (lower sided CGR-CUSUM). Choosing this value smaller leads to smaller control limits and therefore quicker detection times, but can cause delays in detection if the true increase in failure rate is larger than the cut-off. The default of expecting at most a 6 times increase in hazard/odds ratio can therefore be the wrong choice for your intended application area. If unsure, the most conservative choice is to take `maxtheta = Inf`.

*Simulated data set with data of surgery procedures performed at multiple hospitals.*

## Description

Data about patients and their surgery procedure from 45 simulated hospitals with patient arrivals in the first 400 days after the start of the study.

Patient survival times were determined using a risk-adjusted Cox proportional hazards model with coefficients  $\text{age} = 0.003$ ,  $\text{BMI} = 0.02$  and  $\text{sexmale} = 0.2$  and exponential baseline hazard rate  $h_0(t, \lambda = 0.01)e^{\mu}$ . The increase in hazard rate is sampled from a normal distribution for all hospitals:

- $\theta \sim N(\log(1), sd = 0.4)$

This means that the average failure rate of hospitals in the data set should be baseline ( $\theta = 0$ ), with some hospitals experiencing higher and lower failure rates. True failure rate can be found in the column `exptheta`.

The arrival rate  $\psi$  of patients at a hospital differs. The arrival rates are:

- Hospitals 1-5 & 16-20: 0.5 patients per day (small hospitals)
- Hospitals 6-10 & 21-25: 1 patient per day (medium sized hospitals)
- Hospitals 11-15 & 26-30: 1.5 patients per day (large hospitals)

These are then respectively small, medium and large hospitals.

$$H(t|\lambda, \theta, \mu) = \left( \frac{t}{\theta} \right)^{\lambda} e^{\mu}$$

The inverse cumulative hazard (with true hazard ratio  $\mu$ ) by:

$$H^{-1}(t|\lambda, \theta, \mu) = \theta \left( \frac{t}{e^{\mu}} \right)^{1/\lambda}$$
